



MARYLAND RESIDENCY VERIFICATION:

It is necessary to verify Maryland Residency to establish eligibility for the Maryland Owned Preference and Bonus.

The following will be accepted as Maryland Residency Documentation:

1. Maryland State issued Real ID
2. AND one of the following in your name with the matching address:
 - a. Current Real Estate Tax Bill or Residential Rental Contract
 - b. Utility, telephone, cable/satellite bill dated within the last 30 days
 - c. Credit Card or Bank Statement within the last 30 days
3. AND the Residency Affidavit

In order to verify the Horses under Maryland Ownership, the following documentation is required for horses **purchased after January 1, 2021**:

1. Copy of training bill sent by the trainer along with evidence of payment (cancelled check or bank statement), AND
2. Copy of blacksmith, vet, or stall bill for the horse along with evidence of payment (cancelled check or bank statement)

In order to verify the Horses under Maryland Ownership, the following documentation is required for horses **purchased after March 1, 2021**:

1. Copy of the Bill of Sale for the horse identifying previous and new owner along with evidence of payment (cancelled check or bank statement)

Documentation may be submitted via the following methods:

Please be sure to include your contact information on submissions. It is imperative that documentation is received in order to establish eligibility. Bonus privileges suspended for lack of documentation will not be retroactively calculated and distributed.
