**NATIONAL SILVER GLOVES
GENERAL AND SPECIFIC INFORMATION
FOR THE 2018 TOURNAMENT**

1. Silver Gloves Tournaments are open to both male and female boxers.
2. Ages: Age 8 is a stand alone division and boxer must be 8 before entering the local tournament.
 Age 9 - 10
 Age 11 - 12
 Age 13 – 14

Boxers age is determined by the age as of January 1, 2018.
Boxers cannot reach Age 15 before January 1, 2018.

3. For safety reasons boxing rounds will all be one (1) minute with a one (1) minute rest period between rounds.
4. All female boxers must complete the USA Boxing Declaration of Non Pregnancy for girls under 18 at all events.
5. The revised entry form MUST be used for all entries in the tournaments.
